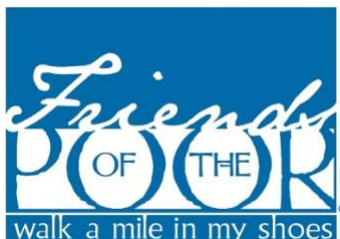

I hereby consent to receive medical treatment which may be deemed advisable in the event of injury, accident and/or illness during this event.

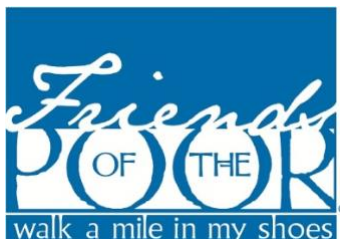
